

## Call for Entries

- The Creede Sculpture Show is open to all sculptors working in a permanent medium
- Artists will be expected to setup and show their work, and may bring as many pieces as will fit in a 10'x10' space
- There is no minimum size requirement for the pieces

## Entry Process

### IMAGES

- Submit images of up to 3 sculptures to be juried
- Up to two images per piece
- JPEG files only
- Label images 1, 2 or 3 to correspond with application
- You may submit files by email or U.S. Mail a CD
- Only digital images will be accepted

### FEES

- Mail non-refundable Jury Fee of \$25 to Creede Arts Council or use PayPal at [creedeartscouncil.com](http://creedeartscouncil.com)
- Submission constitutes agreement by the applicant to conditions specified in the call for entries and CAC reserves the right to final curatorial decision

### IF ACCEPTED

- Artist fee is due by June 8th via US Mail or by PayPal  
**Artist Fee – \$175; Student Artist Fee – \$100**
- Work displayed at the show must be representative of originally submitted work
- Artists should plan to bring their own 10'x10' tent
- CAC may have space for smaller pieces in the main tent
- The artist must provide pedestals and tables if required

## About the Show

The Creede Sculpture Show is a juried show sponsored by the Creede Arts Council in Creede, Colorado.



A unique community with a rich mining and ranching history, Creede has been recognized as one of the Best Small Art Towns with artists, galleries, a theatre and a strong summer tourism economy. CAC's Sculpture Show enhances this vibrant atmosphere. CAC's plan is to install sculptures throughout the community. In 2016, CAC purchased two sculptures to display in the Collins Memorial Art Park.

The 2017 show will be held on August 18-20 in the Basham Park area.

Judges will award a total of \$1,000 to winning sculptures. One piece from the show will be purchased for up to \$4,000 by CAC for permanent outdoor display.

The Jury Committee will determine which artists' work will be included in the show. Accepted artists will be provided with space to show and sell their work.

Artists will be invited to the opening reception on August 18.
