

ELIGIBILITY

Thank you for your interest in the Creede Arts Council (CAC) National Small Print Show (NSPS). Artists from all 50 states and Canada are eligible to submit up to 3 original prints. This form may be copied and shared.

CALENDAR

- April 10:** Prints, entry form, SASE, fees, and postage due must be postmarked by April 10th
- April 29:** Mailing of Juror's results
- May 27:** Opening night reception at Creede Repertory Theatre (CRT)
- June 25:** Closing day at CRT
- July:** Travelling exhibit

AWARDS

Cash awards will be given for Best in Show, 2nd and 3rd Place and for two Honorable Mention awards.

Approximately 30 pieces accepted for travelling show.

All prints will be selected at the discretion of the juror and announced at the opening reception.

PRINT SPECIFICATIONS

All accepted prints will be displayed under glass. Prints that do not meet **ALL** of the following requirements will be **disqualified**:

- Print must be matted and backed with white mat board
- Mat must measure 10"x10" (outside) with at least one inch of matting around print
- Front and back mats must be hinged
- No foam core backing. Use white mat board only.
- No glue. Use tape only. Prints need to be examined, do not use any glue on the print or matting.
- Separate matted prints with protective paper
- Each print must have label on back identifying: Name of artist, title of print, medium, and price.
- Prints must be original and handmade
- Prints cannot have been submitted to or shown in any previous Creede Small Print shows
- No cropped works and no digital, copy machine, photograph, inkjet, computer or giclee

ENTRY FEE & SHIPPING PRINTS TO THE CAC NSPS

- \$40 nonrefundable fee for up to 3 pieces. Make checks payable to "Creede Arts Council"
- All work **must** be shipped via **USPS** in Priority Mail sacks or boxes

RETURN SHIPPING OF JUROR CARD

Enclose a self-addressed and stamped return envelope (SASE) for artist's Juror Card

RETURN SHIPPING OF PRINTS

If return postage is not proved as follows, prints **WILL NOT** be returned:

- Artist is responsible for prepayment of USPS return shipping and any desired insurance. (USPS only)
- Send this prepayment as a check made out to the "Creede Arts Council"
- Do not send stamps

SALES

- This event is a fundraiser for the CAC, so we strongly encourage sales, but sales are not required
- The CAC retains a 35% commission on all works sold
- We encourage multiple sales of an image
- If additional prints are sold, the artist will be notified no later than August, and the artist has 2 weeks to provide the additional prints to the CAC
- Extra prints must meet the same "Print Specifications" noted for entries
- If a print is not for sale (NFS), include insurance value on the entry form
- Unsold prints will be returned in September
- Checks for sold prints will be sent in September in a separate envelope

LIABILITY

The CAC is responsible for work only while it is on or in the premises of the CAC or the selected venue. We reserve the right to scan prints for publicity, educational purposes, and the NSPS catalogue.

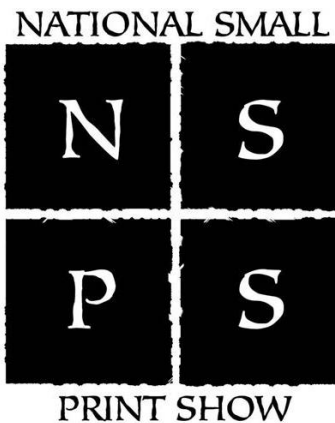
